Initially, journals only functioned as print and electronic journal media that accommodated and published research results from theses/final assignments and/or part of theses/final assignments for students of UIN Prof. KH. Saifuddin Zuhri Purwokerto (S.1 and S.2), from multidisciplinary science. However, due to subsequent developments with a wider audience, the journal has succeeded in inviting scholars and researchers outside the Institute to contribute.

Thus, Indonesian and non-Indonesian scholars have enriched the research published in journals. Although from the beginning Raushan Fikr did not present high-quality scientific articles, the improvement — in terms of format, style, and academic quality — never stopped. Now with articles written in Indonesian, Arabic and English and with fair peer-review procedures, Raushan Fikr continues to publish research and studies related to Islamic studies with various dimensions and approaches.
